

Memorandum of Understanding

This Memorandum of Understanding ("MoU") between Ankur Pratishthan ("Ankur") and Kirti M. Doongursee College, is executed on December 9, 2022 at Mumbai.


A. Background: -

- 1) Ankur Pratishthan ("Ankur") is a Non-Governmental Organization (NGO) working for the overall development of destitute and needy children through its various activities which are conducted throughout the year and conducts it through its self-motivated team of volunteers including college going students.
- 2) Kirti M. Doongursee College is an Educational Institution imparting academic education to students and is an institution which encourages its students to take up philanthropic work not only as a part of their curriculum but also because their good conscience wants their students to participate in the work relating to social development.
- 3) Both the organization in order to cooperate and help each other to achieve the common goal of contributing to the social development by encouraging the participation of college going student in the social welfare activities are entering this Memorandum of Understanding on the terms set out herein under.

B. Terms and Conditions

- 1) College shall allow Ankur, its volunteers and members, to make presentation relating to the work carried out by Ankur to all the students across the streams in order to make an appeal to the students of the college to participate in the activities of students as volunteers.
- 2) College shall grant permission to Ankur to conduct its training session for the volunteers of Ankur in any of the premises of Mumbai Campus.
- 3) Principal, Teacher, Staff shall be allowed to visit the training sessions and activities carried out by Ankur with prior intimation.
- 4) Selection criteria, standard and procedure of students shall be the sole discretion of Ankur.
- 5) Ankur shall issue certificate to the students of the college upon the completion of task/activities or tenure for which internship is provided subject to the student fulfilling the criteria required to obtain internship certificate.
- 6) In any event Ankur finds any issues with the student or due to any circumstances is not to issue a certificate to the student, shall in writing in form the reasons to the principal of the college.
- 7) Ankur shall take permission from college for approaching the student in college seeking their participation in Ankur activities and also for conducting training sessions for its volunteer and the college shall grant permission for the same.

- 8) Engagement between student and Ankur, after the completion of internship/ activity, shall be mutually decided by Ankur and student and college shall have no say in such agreement.
- 9) Ankur and College both shall have right to use each other's logos for activities and training which is being jointly organised by both and even on their respective website representing each other as their corroborators.
- 10) College shall not object Ankur from affixing the logos and names of other colleges and/or institutions, who have participated in the activity/event/ project organised by Ankur, along with logo of college.
- 11) Ankur shall not object College from affixing the logos and names of other NGO and/or institutions, who have participated in the activity/event/ project organized by college, along with logo of Ankur.
- 12) The authority to use logo shall continue till the subsistence of this MoU.
- 13) This MoU shall not restrain Ankur and College from entering into an MoU with other colleges/organizations/institutions on such terms and conditions as they may find it fit, but shall ensure that they shall not enter into any conditions with third party to an effect that it jeopardizes the terms and conditions and corroboration agreed herein.


C. Tenure of MoU

- 1) The tenure of this MoU shall be for the period of 5 years from the date of execution.
- 2) The MoU can be terminated before 5 years provided a letter of termination is issued one month prior to the dated of termination.
- 3) Letter of Termination of MoU if issued shall have no effect unless the period of internship or participation of students in any of the activities in Ankur is concluded.


D. Sets

There shall be 2 sets of this MoU which shall be retained by each party to the MoU and both shall be treated as original.
