3. The Fund.

The Donor shall place all of the Contributed Amount in a College bank account via Cheque under the name of the director. The Donor and the College shall solely use the Fund to support the Program Activities as stated in this Agreement. No part of the Contributed Amount shall be used for overhead support and no offset or deduction can be made from the Contributed Amount for any direct or indirect costs, including development or fundraising charges or tax levies.

4. General Terms.

- a) Term. The term of this Agreement is from the Effective Date to the later of January 31, 2024, or until the Donor and the College have spent all of the Contributed Amount, unless earlier terminated pursuant to this Agreement.
- b) Agreement shall begin on the Effective Date and shall continue until renewed every one year by the Donor in January up-to three years at discretion of the Donor.
- c) Termination. The Donor has the right to terminate this Agreement if:
- i. the Donor or the College breaches any term of this Agreement;
- ii. the Program Activities are not advancing the Program's Mission; or
- iii. If the Agreement is terminated, the College is not relying on the Donor's proposed funding under this Agreement to incur any obligation or take any action or inaction.
- iv. If any dispute arose in future the decision of arbitration by College will be final and binding on both the parties.
- d) Donor Notice. The College shall notify the Donor prior to making this Agreement publicly available or upon receiving records requests for this Agreement or related information.

- e) Entire Agreement, The terms contained in this Agreement supersede all prior oral or written agreements and understandings between the Parties related to the matters contained in this Agreement and constitute the entire agreement between the Parties with respect to the matters contained in this Agreement.
- f) Order of Precedence. If there is a conflict between the terms of this Agreement and the terms in the Proposal, this Agreement controls.
- g) Other Support. If the University and Donor mutually agree, the Donor may also contribute in kind services to the University to help promote the work of the University, the Program, or the University faculty, students, and staff.
- h) Amendments. No amendment to this Agreement will be effective unless it is in writing and signed by the Parties.
- i) Severability. The terms of this Agreement are severable. If any court of competent jurisdiction construes any term of this Agreement to be illegal, invalid, or unenforceable, the legality, validity, and enforceability of the remaining terms of this Agreement will not be affected.
- j) No Waiver. No delay or failure by any Party to enforce any right or claim under this Agreement is a waiver of such right or claim. Any waiver by any Party of any term of this Agreement is not a further or continuing waiver of such term.
- k) Third Party Rights. This Agreement does not confer any rights or remedies upon any third party other than the permitted assigns of the Parties.
