## MEMORANDUM OF UNDERSTANDING

### 1. Preamble:

The purpose of this Memorandum of Understanding (MOU) is to clarify the expectations, roles, and responsibilities of the collaboration between our two organisations (Parties). This is not a legally binding agreement.

The MoU is entered into on the 11<sup>th</sup> Dec, 2023 and signed between DES' Kirti M Doongursee College of Arts Science and Commerce (Autonomous), Dadar and Akshay Educational Institute, Prabhadevi, Mumbai.

### 2. Objectives of the MoU:

- a) To provide guidance on Competitive Examination like -
  - i) State Bank of India - Probationary Officer





- ii) The Institute of Banking Personnel Selection (IBPS) IBPS- Probationary Officer
  - iii) Life Insurance Corporation of India (LIC) - Assistant Administrative Officer
  - iv) Staff Selection Commission (SSC)
  - v) Railway Recruitment Board (RRL)
- b) To Provide Guidance for Higher Education like MBA-CET/CAT/ATMA, MCA-CET, CMAT, GMAT.
  - c) To give on Job training to the learners.
  - d) To Provide Internships to the students
  - e) To organise Seminar, Workshops and Conferences

**3. Technical Areas of collaboration**

- a) Skill Development
- b) Capacity Building
- c) Incubation
- d) Training and Placements

**4. Beneficiary : Students from Under graduates, Post graduates programmes**

**5. Proposed Mode of Collaboration:**

Kirti M Doongursee College of Arts Science and Commerce, Dadar and Akshay Educational Institute, Prabhadevi , Mumbai, wish to collaborate through the following terms and conditions to extend training, guidance, to conduct capacity building workshops, and provide on job training facility to the students.

**6. Terms and Conditions:**

- a) This MoU may be amended, renewed & terminated by mutual written agreement of the institutes at any time.
- b) Either institute shall have the right to terminate this MoU upon 30 days prior written notice to other institute.





- c) To conduct training / workshops/ on Job training /awareness programmes.  
No fees will be collected /charged to students, however if its highly necessary it will be decided by discussion with both parties.

#### **7. Confidentiality**

Kirti M Doongursee College of Arts Science and Commerce Dadar and Akshay Educational Institute, Prabhadevi , Mumbai agreed to hold in confidence all information/ data designated by the institute as being confidential which is obtained from either institutes or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other institute.

The above confidential clause under this MoU excludes the information / data possessed by either institute before entering in to this MoU or Independently developed and / or information already available through public domain.

#### **8. Duration of MoU :**

This MoU, unless extended by mutual written consents of the institutes, shall expire in 3 years after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended for another 2 years by mutual consent.

#### **9. Coordinators:**

Both institutes will designate their Head /Coordinators of the Organization who will be responsible for co-ordination & implementation of this agreement.

#### **Arbitration Clause**

In the event of any dispute arising between the parties hereto, it shall be the endeavor of the respective Heads of the Institution to first make an attempt to resolve the dispute amicably by mutual discussion and deliberations in a spirit of independence, mutual respect and shared responsibility, failing which the dispute shall be referred to Arbitration. The Arbitration shall be conducted as per the provisions of Arbitrations and Conciliations Act 1996. The Arbitral tribunal shall consist of a Sole Arbitrator, to be appointed mutually by both the institutions. The award of the Tribunal shall be final and binding on both the institutions.





**10. Modifications to this MOU:**

This Memorandum may be modified with supplemental written agreements signed by the parties and can be terminated in writing, in whole or in part, by consensus of the parties.

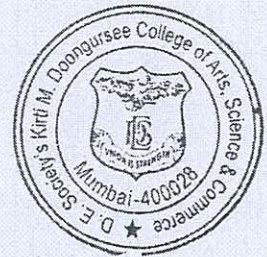


