1. Title of the Practice: - Bridging the gap of digital divide - ERP based exams

## 2. Objectives of the Practice

- 1. To automate and systematize the examination and result processes using technology.
- 2. To make the process efficiently paperless.
- 3. To vitalize the spirit of accountability and transparency in the process of conducting the exams

### 3. The Context

The most crucial part of the educational curriculum is the process of conducting the exams in a transparent manner. The fraudulent and dishonest practices in the examination may surface despite instituting a stringent system of administrative vigilance. Colleges have to deal with excessive paperwork to carry out exam-related activities. Besides, the process of result preparation was a lengthy one. In view of this problem, our institution has decided to automate the exam and result procedures through an ERP system. This has not only eased the drudgery of excessive paperwork but has also been very expedient in the matter of conducting exams on time and declaring the results within the stipulated time.

### 4. The Practice

In the year 2018 the MasterSoft system of ERP was incorporated. The college used the examination module of the system. The management arranged several rounds of training sessions for teaching and non-teaching staff who were involved in the examination and result process. This process is extremely user friendly and suited to the changing times. All pre-exam activities like preparing student exam schedules, hall tickets, room allocation, question papers, etc., and post-exam activities like result generation and declaration, mark sheets/grade card creation and printing, MIS reports on students' performance, etc. are carried out seamlessly. The ERP system had been immensely beneficial during the period of the Covid-19 pandemic. The system sends text messages to students about all exam related information.

### 5. Evidence of Success

Our institution has been successful in conducting the exams in a transparent manner and in addition errors have reduced substantially. Malpractices by students during exams have also been curtailed significantly as the system automatically detects it, which enables us to apprehend the wrong doers. We conduct a thorough training session for students in the form of mock tests to familiarize them with the system and call attention to non-indulgence in any malpractices. The orientation has paid


### TYPE OF EXAM FOR COURSE/SUBJECT SELECTION
